The Board of Control for Cricket in India (BCCI) has announced a Workshop & Examination for Match Referees to be conducted in June 2025. The Uttar Pradesh Cricket Association (UPCA) is required to nominate **three fresh candidates** for this opportunity.

Eligibility Criteria:

Male Candidates:

- Former International or First-Class cricketers from UPCA.
- Must have played a minimum of 20 First-Class matches.
- Should have retired from active cricket at least five years before the 2024-25 domestic season (i.e., the last season played should be 2018-19).
- Must be below 45 years of age as of 31st August 2025.

Female Candidates:

- Former International cricketers or those who have represented the state in at least 20 senior-level matches conducted by BCCI.
- Should have retired from active cricket at least five years before the 2024-25 domestic season (i.e., the last season played should be 2018-19).
- Must be below 45 years of age as of 31st August 2025.

Application Process:

Interested candidates must submit their Application Form for Nomination (Sheet Attached) with the details along with their CV and Aadhar card.

Submission Deadline:

The last date to submit applications is 08th February 2025. Applications should be sent via email to upcaknp@gmail.com.

Note: If the number of applications exceeds the available quota (3 candidates), UPCA will conduct a pre-qualification exam in the second week of February 2025 to shortlist nominees.
